The Chairperson welcomed all the members present and gave a brief background of the formation of the IQAC Cell as required under the UGC Regulations and the guidelines of the NAAC.

The following were the proceeding of the meeting

- 1) Approval of minutes of previous meeting

The Coordinator, IQAC placed the minutes of the previous meeting held on 6th March 2019 before the committee. The committee considered and confirmed the same. The committee further discussed the action taken on earlier decisions of the Internal Quality Assurance Cell.

## 2) Techno-Virsa 2019 Event

The chairperson appreciated the efforts of the students and faculty members of the University for organizing a two-day technical and cultural event. The program included Ad mad show, quiz competition, budding chef, mehndi, poster-making, face painting competition along with Gidda and bhangra performances, western group dance, western solo dance, Indian classical dance, light vocal, folk songs and technical events such as debugging competitions and gaming competitions.

## 3) National Moot Court Competition

Two-day 4th national moot court competition was organized by University School of Law (USL) on April 08, 2019. More than 34 teams from all over the country participated in the competition. The overall winner was the team from the University School of Law and Legal Studies in Dwarka, Delhi.

## 4) Budget Utilization

As discussed and approved in the first meeting of IQAC dated Sept 17, 2018 regarding the budget allocation for the financial year 2018-19, a budget of Rs.50 crores (approx) was accepted. Against this budget a sum of Rs.451, 978, 986 was utilized as per the budgetary provision. The audited income statement for the financial year ended 31<sup>st</sup> March 2019 has been attached herewith for future reference.

The members also noted that allocation of funds of Rs. 15 lakhs as Seed money for organizing Seminars, Conferences, workshops and incentives for promotion of research activities allocated different departments has been fruitfully utilized for the objectives for which it was sanctioned.

It was communicated that minutes of meeting of every meeting should be maintained separately and uploaded on the University website.

The meeting ended with a vote of thanks to the Chair.
